NOW on this ____ day of _____, 20____ the above-captioned matter comes before the Court. The Muscatine County Sheriff having certified to the Court that the Muscatine County Jail has an in-home jail diversion program, and the Court, having given consideration to the nature and circumstances of the Defendant's offense and risks of noncompliance with correctional requirements by the Defendant, finds that the Defendant may be transferred to the jail diversion program of the Muscatine County Jail subject to the Defendant meeting all operational requirements of that program.

IT IS THEREFORE ORDERED that the Defendant shall be transferred by Muscatine County Jail staff to the jail diversion program of the Muscatine County Jail subject to the Defendant meeting all operational requirements of the in-home detention/work program. Defendant shall serve _____ days in the Muscatine County Jail Diversion Program to satisfy the jail sentence imposed.

IT IS FURTHER ORDERED that violation of the Muscatine County Sheriff's rules and conditions of the jail diversion program by the Defendant may result in termination from the program and prosecution for contempt of court, probation violation or escape. The defendant is in the custody of the Muscatine County Sheriff during the days scheduled to participate in the jail diversion program. Therefore, the defendant's person and residence are subject to search by the Muscatine County Sheriff to ensure defendant's compliance with the rules of the program and Court orders. The defendant must cooperate with the installation of electronic monitoring equipment to their person and in their residence. The defendant may not leave their residence during the period of in home incarceration unless directed by the Muscatine County Sheriff for community work service or for medical emergency or sudden emergency within the home that presents a danger to the defendant's safety or well being. The defendant must perform community work service as directed by the Muscatine County Sheriff. The defendant must comply with all requests of the Muscatine County Sheriff for random drug or alcohol testing. The defendant must abstain from the use of alcohol, controlled substances or prescription drugs unless prescribed by a physician while participating in the jail diversion program.

IT IS FURTHER ORDERED that the Muscatine County Sheriff, or his designee, shall notify the Court of any violations of the rules and conditions of the in-home detention program by the Defendant as soon as practicable thereafter.

IT IS FURTHER ORDERED THAT DEFENDANT SHALL APPEAR AT THE MUSCATINE COUNTY JAIL NO LATER THAN MONDAY, _____ to pay the required fee and to schedule the time the defendant will participate in the jail diversion program. Failure to report as required may result in termination from the program, contempt of court or violation of probation. Defendant must complete the jail diversion program within 60 days after sentencing.

All other aspects of the Courts Sentencing order remain as previously ordered.
